Information on the processing of navigation data

In compliance with the Privacy Code (art.13 of Legislative Decree No. 196/2003, and subsequent amendments and additions) and the regulation (EU) **GDPR** n. 2016/679, **Coder International** wishes to provide the following information on the processing of personal data relating to the user or navigator ("interested") who consults this website. The information is provided only for the **Coder International** website and not for other websites that may be consulted by the user through the link (for which reference is made to the respective privacy information / policy).

Types of data processed

Navigation data. During their normal operation, the IT systems and software procedures used to operate this website acquire some personal data, the transmission of which is implicit in the use of Internet communication protocols. This is information that is not collected to be associated with identified interested parties, but which by its very nature is necessary, through processing and association with data held by third parties, the user to identify the navigating users. This category of data includes the IP addresses of the names of a domain of the computers registered by the users who connect to the site, the addresses in URI (Uniform Resource Identifier) notation of the requested resources, the user of the request, the method used in submitting the request to the web server, the size of the file obtained in response, the numerical code indicating the status of the response given by the web server (successful, error, etc ...) and other parameters relating to the operating system and computer environment of the 'user. This data is managed for the sole purpose of obtaining anonymous statistical information on the use of the site and to check its correct functioning.

Cookie

Session cookies. The use of so-called session cookies (which are not persistently stored on the user's computer and disappear after a certain period of time) are strictly limited to the transmission of session identifiers (consisting of values generated by the web server) necessary to activate secure browsing and efficient use of the site and its applications. I c.d. session cookies used on this site avoid the use of other IT techniques concerning prejudicial to the confidentiality of users' browsing. This website uses some systems that analyze user navigation to create statistics on visits or to improve the offer of contents and possibly position targeted advertising on web pages.

Provision of data other than navigation data

Apart from what is specified for navigation data, the user is free to provide personal data registered in the registration / request forms. The optional, explicit and voluntary sending of your e-mail address through the registered forms, the subsequent acquisition of the sender's address, necessary to respond to requests, as well as other personal data entered in the form.

Persons in charge and methods of data processing

For the performance of the activities outlined above, personal data may be known by the staff in charge of **Coder International** (employees and collaborators), the structures in charge of services and web services, and are also involved through computerized procedures and electronic communication systems, protected by appropriate security and confidentiality measures, as well as with methods and logics consistent with the purposes pursued and for the retention times strictly necessary for the fulfillment of contractual and legal obligations. The personal data thus acquired will not be disclosed and will be communicated to the competent public subjects and authorities for compliance with regulatory obligations or for ascertaining responsibility in the event of computer crimes against the site as well as communicated to, or allocated to, third parties, operating in Italy and abroad, which **Coder International** uses for the performance of tasks and activities of a technical and organizational nature instrumental to the functioning of the website. Furthermore, navigation data are processed by **Coder International** for further aspects of improvement and development of **Coder International** web services.

Rights of the interested parties

The interested party may, at any time, assert their rights, as provided for in the Privacy Code (art. 7 of Legislative Decree no. 196/2003). In particular, the interested party may request access to the data concerning him held by **Coder International**, know how they are processed, update them, integrate and correct, if inaccurate or incomplete, request their cancellation or blocking if processed in violation of the law, and oppose their treatment for legitimate reasons or, in any case, when they are used for commercial, promotional and advertising purposes.
